1. Project/Topic Background

The programme on Economic and social participation of vulnerable displaced and local populations in the South Caucasus /EPIC was designed with the objective to improve socio-economic participation of vulnerable displaced and population of selected host communities in the South Caucasus. The objective is translated into three closely related fields of activity:

- 1. Strengthening capacities of public actors to promote economic and social participation of vulnerable population, both displaced and local
- 2. Increasing employability of target groups with a special focus on women and youth;
- 3. Enabling private sector actors to apply new measures to promote local economic development and to promotion business start-ups
- 4. Empowering communities and their individuals to actively participate in society.

The South Caucasus, since 1991 has witnessed a number of regional conflicts that resulted in proportionally huge displacements of population and large communities of displaced in Armenia, Azerbaijan and Georgia. Different factors hamper the economic and social integration of displaced population in their host-communities, among them a lack of vocational qualifications and key competencies that match the demands of the local labour market and a lack of opportunities to participate in decisions about the local development in their host-communities.

Due to the war in Syria there was another significant movement to Armenia primarily of people with ethnic Armenian background. According to the Government of Armenia and UNHCR, the number of persons displaced from Syria currently present in Armenia is estimated to be around 15 000-17 000. While these figures are small in absolute numbers, they constitute a significant challenge for a small country such as Armenia. The government needed to expand its capacity to respond to the humanitarian challenges, elevate its process of naturalisation and prepare for the integration of thousands of new citizens into the labour market and larger society.

The RA government introduced a number of measures assisting persons displaced from Syria, offering them a variety of protection options, namely by way of (i) simplified acquisition of citizenship, (ii) accelerated asylum procedures or (iii) privileged granting of short, mid-term or long-term residence permits.

The quite heterogeneous and diverse in terms of professional background and skills group of Syrian Armenians (SAs) is welcomed with open arms by the RA government and society. This combination of i) SA enthusiasm, broad skills, experience especially in the Middle East and Mediterranean and service-orientation together with ii) Armenia's declared interest and commitment for their integration supported by the international community offers excellent preconditions to tap into the many economic opportunities. This can possibly help Armenia's economy to innovate and grow and open new markets regionally and internationally.

The core problem of SAs for their economic integration in Armenia had been the lack of access to existing business networks as well as to employment and business support programmes and finance in order to rebuild their livelihood. Therefore, the project for "Economic Integration of Syrian Refugees in Armenia" (EISRA) was commissioned by the German Federal Ministry for Economic Cooperation and Development (BMZ) to improve the economic integration of Syrian refugees in Armenia. It was attached to the GIZ programme 'Private Sector Development in South Caucasus (PSD SC)' and its country component in Armenia. The project lasted for 3 years and ended in March 2018.

The Armenian component of the technical cooperation (TC) measure under the EPIC programme will be launched in October 2018 aimed at economic integration of displaced persons from Syria.

It is well known that Syrian Armenians are urbanised and concentrated mainly in the capital city Yerevan. Still some of them are also settled in the regions of Armenia, however there is no comprehensive data on the numbers, profile and needs of those located in the regions. To fill in this gap the project plans a mapping exercise in order to acquire the up-to-date information on SAs settled in the regions of Armenia. It is envisaged that the mapping will be done in close cooperation with the RA State Employment Agency (SEA) of the RA Ministry of Labour and Social Issues. The assignment implies also close cooperation with other state intuitions, such as RA Ministry of Diaspora, RA Ministry of Territorial Administration, RA State Migration Service and local municipalities to ensure comprehensive data collection not only with regard to the job-seekers but also including those who are not registered at the regional centres of the SEA.

2. Conditions of the assignment

2.1 Objective tasks and responsibilities

a. Objective

Establishing a comprehensive and user-friendly digital database on the target group residing in the regions of Armenia (including municipalities close to Yerevan). Creation and making accessible a comprehensive database and more precise and up-to-date needs assessment for the target group in the regions will thoroughly inform the various stakeholders involved in the field of SA economic integration and take well-informed decisions on interventions.

a. Tasks and deliverables

I Design a database concept

Merging the existing databases structures (e.g. demographics, population, employment status, economic/employment sectors, potentials, desires, needs, education, skills) and a methodical approach to compile the (still) needed data, which shall serve as a basis for the interpretation of the data leading to the identification of relevant activities for the target group (need assessment). The needs assessment should be differentiated/categorised by socio and economic conditions of the target group (e.g. age, gender, sector, education, unemployed, employed, entrepreneur, income, number of family members living in one household). socio-economic background). A user-friendly database shall be established preferably web-based, which will allow administrative access for update and maintenance, as well as it might offer decentralized access to information for the stakeholders. The concept should provide data protection conditions for sharing the database with the stakeholders. Stakeholders shall be trained further supplementing and using the data base, therefore it shall be set up in a comprehensible way.

II Merging existing databases and collecting information

Implementation of the created and approved database design by combining already existing databases (taking into consideration also the privacy rights and data protection), collecting the missing data about the target group and their needs. The database should reflect the data of SAs settled in the regions of Armenia who are looking for support and want to be engaged in activities offered by supporting organisations. The contracted company should assume responsibility for networking and engaging with related stakeholders from state and non-state actors.

III Needs Assessment

Conduct survey based on the created database to identify and analyze the needs of the target group. The survey methodology should apply qualitative and quantitative approaches to identify key obstacles Syrian Armenians face in the regions and measure the level of their economic integration and associated specific needs.

2.3 Conditions and payment terms

2.4 Coordination and communication

The hired company needs to meet the following requirements:

- Proven expertise in the area of conducting research and needs analysis similar to the assignment (proven by references attached to the offer)
- Proven expertise in advanced statistical research skills and database administration to be used especially by practitioners/non-researchers
- Ability to access, establish and manage networks
- Proficiency in English and Armenian language (written and spoken), knowledge of Western Armenian and Arabic languages and mentality are an asset.
- Deliverables in British English
- Prior experience in dealing with Syrian Armenians in Armenia and their economic integration is a strong asset (proven by references attached to the offer)

- Excellent understanding of and ability to meet the demands and standards of an institution of international development cooperation
- Excellent understanding of how to approach and communicate with private businesses/start-ups, intermediaries, international organisations, government
